On behalf of the Commission for the Purchase of Products and Services of the Blind and Other Severely Handicapped Individuals (State Use Law Commission), I am pleased to present you our 2010 Annual Report.

We strive to uphold the purpose of the State Use Law Commission to "further the policy of the State to encourage and assist blind and other severely handicapped individuals to achieve maximum personal independence through useful and productive gainful employment by assuring an expanded and constant market for their products and services."

During fiscal year 2010, 437 individuals with visual impairments and other disabilities were employed in jobs set aside under the State Use Law. The total gross wages for these individuals was \$3,872,888. We are pleased to have added another year of growth to the set-aside program's history.

In this year's report, we feature the personal stories of three individuals who have been employed through the State Use Law. We hope these stories help illustrate the value that this law provides for Delawareans with visual impairments and other disabilities, the agencies that support them, and the public and private customers of their services.

Executive Summary

This annual report reflects the results of the State Use Law set aside contracts during fiscal year 2009-2010. Because jobs have been "set aside" by the State to specifically employee individuals with visual impairments and other disabilities, 437 people were able to acquire gainful employment. The total gross wages paid to these individuals was \$3,872,888. Continued growth in this fiscal year is reflected in the \$617,923 in sales experienced by the Delaware Industries for the Blind and the 5,534 remanufactured cartridges sold to the state at a reduced cost. Janitorial services were also provided at 55 sites across the state's three counties.

In Delaware, there are seven major contracts set aside for people with visual impairments and other disabilities. These services are provided by the following agencies as listed below:

> Document & Mail Preparation Services • KSI Electronic Goods Recycling • DelARF Engraving & Promotional Items • DIB Janitorial Services • DelARF Remanufactured Toner Cartridges • KSI Rubber Stamps • DIB Temporary Employment Services • DelARF

A major focus for this year was expanding awareness of the State Use Law and the State's procurement requirements. The Chair sent letters to all Cabinet Secretaries, and County and State Police to make them aware of the requirements and availability of the State Use Law. The Commission also began to explore the possibility of working with prison industries and school districts who may wish to use promotional materials created by the Division of Industries for the Blind. The Commission approved three (3) new set aside janitorial contracts. No recommendations for changes in the law are suggested.

The State Use Law Commission serves to oversee and guide the contracts of the set-aside program. During the 2009-2010 fiscal year, the commission met seven times (11/19/2009, 12/17/2009, 02/18/2010, 04/15/2010, 05/20/2010, 06/17/2010, and 07/15/2010).

Victoria Cash is happy to tell you why you should buy your printer cartridges from Kent Sussex Industries (KSI). "Our cartridges are cheaper, 100% guaranteed, and they help people with disabilities keep their jobs," she would explain. Victoria is one of six employees at KSI that works in their "I like how the job lets me live on my own and pay my own bills."

Cartridge Service Division. KSI is a Milford-based nonprofit agency that provides rehabilitation and employment services to individuals with disabilities in the pursuit of their potential in employment and meaningful participation in their communities.

Victoria joined KSI two years ago and found her niche in Cartridge Service after exploring other opportunities at KSI. Her daily tasks include manufacturing, filling, prepping, testing, and boxing printer cartridges. These cartridges are sold to individuals, businesses, schools, hospitals, and government agencies. During an average day KSI processes between 40-70 cartridges. "Victoria has excelled in Cartridge Service and we have been very impressed by her," said KSI Employment Manager Stefanie Hammond.

Since joining KSI, Victoria has met a number of personal goals, including living independently in her own apartment. When she talks about what she likes best about her job, she struggles to narrow down her list. "I like everything about it. The supervisors that help us get the job done and make the day go by fast. I like doing different things during the day and moving around in my job. But I like how the job lets me live on my own and pay my own bills." Delaware State Code Title 16 Health and Safety Disabled and Partially Disabled Persons Chapter 96. State Use Law

The purpose of this chapter is to further the policy of the State to encourage and assist blind and other severely handicapped individuals to achieve maximum personal independence through useful and productive gainful employment by assuring an expanded and constant market for their products and services, thereby enhancing the dignity and capacity for self-support of blind and other severely handicapped persons, and minimizing their dependence on welfare as well as the need for the State to provide costly institutionalization.
